## What data do we collect?

Eureka!Europe collects data from you when you sign up to receive more information, fill out a form on our website or register to attend an event. We may collect, use, store and transfer different types of personal information including:

- Your name and contact details such as phone number, address, email address and telephone numbers
- Information about how you use our website
- Details regarding your marketing and communication preferences
- Technical Data which could include internet protocol (IP) address, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this website.

## How do we collect, use and store your data?

### Collecting your data

You directly provide Eureka!Europe with most of the data we collect. We collect and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Subscribe to our publications and notifications

- Request information to be sent to you
- Register to attend any of our events or courses
- Give us feedback

Our Company may also receive your data indirectly from the following sources:

- Technical Data from the following parties: analytics providers such as Google based outside the EU, advertising networks and search information providers;
- Identity and Contact Data from publicly available sources such as Companies House and the Electoral Register based inside the EU.

## Using your data

Our Company collects your data so that we can:

- Manage your account and provide our services to you
- Email you with updates and details of other services. (If you have agreed to receive marketing, you may always opt out at a later date).
- Deliver the requirements of the contract we have with you or about to enter with you
- Deliver our legitimate interests which means conducting and managing our business to give you the best and most secure service.
- Comply with a legal requirement

When Eureka!Europe processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

Generally we do not rely on consent as the basis for processing and using your personal data. If however we expressly tell you that we are relying on consent, then you can withdraw that consent at any time.

## Storing your data

Eureka!Europe securely stores your data on commercial cloud based servers or on encrypted mobile devices. We limit access to your personal data to those employees, contractors and formal partners who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected breach or loss of personal data and will notify you and any applicable regulator of a suspected breach where we are legally required to do so

We will only keep your data for as long as necessary to fulfill the purposes for which we are collecting it. This includes for the purposes of satisfying any legal accounting or reporting requirements. After this time we will securely destroy your personal information

In some circumstances we may anonymise your personal data so that it can no longer be associated with you, in which case we may use such information without further notice to you.

We may retain your personal information on file on the basis that a further opportunity may arise in the future and we may wish to consider you for that. We will only do this if you have given your explicit consent for us to retain your details for this purpose as part of the recruitment process.

### Your data Protection Rights

Eureka!Europe wants to ensure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**Access** - You have the right to request copies of your personal data.

**Rectification** - You have the right to request that we correct any information you believe is inaccurate or incomplete

**Erasure** - You have the right to request that we erase your personal data, under certain conditions.

**Restrict Processing** - You have the right to request that we restrict the processing of your personal data, under certain conditions.

**Object to processing** - You have the right to object to us processing of your personal data, under certain conditions.

**Data Portability** - You have the right to request that we transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
